Re: CFTC Regulation 40.6(a) Certification: Submission of Amendments to the Nodal Exchange Rulebook

Dear Mr. Kirkpatrick:

Nodal Exchange, LLC (“Nodal Exchange” or “Exchange”) is notifying the Commodity Futures Trading Commission (“CFTC” or “Commission”) that it is self-certifying amendments to the Nodal Exchange Rulebook (“Rules”) pursuant to Commission Regulation 40.6(a). The Exchange is amending Appendix A – Contract Specifications for all Nodal futures contracts. The Exchange intends to implement the amended Rules on March 20, 2025.

The Exchange is amending Appendix A – Contract Specifications for all Nodal Exchange futures contracts to standardize the specifications across product class and to provide clarity to market participants. These revisions have no effect on the economic characteristics of the contracts in accordance with CFTC Regulation 40.6(d)(i).

The Contract Specifications for power futures are being amended to add the item “Settlement Method”, remove the item “Hours of Trading”, rename “Lot Size” to “Contract Size”, rename “Min Price Fluctuation” to “Minimum Price Fluctuation”, remove item “Minimum Tick”, add item “Settlement Price Precision”, remove item “First Trading Day”, standardize “Contract Series”, remove item “Fixed Price”, rename “Final Settlement (Payment) Date” to “Final Settlement Day”.

The Contract Specifications for natural gas futures are being amended to remove the item “Block Name”, remove the item “Screen Name”, remove the item “Hours of Trading”, standardize the item “Unit of Trading”, rename item “Lot Size” to “Contract Size”, add item “Minimum Price Fluctuation”, remove item “Minimum Tick”, clarify “Last Trading Day”, remove item “Fixed Price”, rename item “Final Settlement (Payment) Date” to “Final Settlement Day”, and remove item “Margin Unit”.

The Contract Specifications for environmental futures are being amended to remove item “Hours of Trading”, rename item “Lot Size” to “Contract Size”, add item “Minimum Price Fluctuation”, remove item “Minimum Tick”, and rename item “Final Settlement (Payment) Date” to “Final Settlement Day”.

Exchange management has assessed the amendments to the Rules, and their compliance with applicable provisions of the Act, including the Commissions Regulations and the Core Principles. Nodal Exchange has identified that the amendments may affect the following Core Principles as follows:

Core Principle 2 – Compliance with the Rules: The amendments to the Rules provide clarity and consistency with the Act for compliance with the Rules. Appendix A is applicable to all Nodal Exchange Participants.

Core Principle 3 – Contracts Not Readily Subject to Manipulation: The applicable Futures contracts are not readily subject to manipulation and are based on established and liquid underlying cash markets. Trading of the contracts is monitored by the Exchange.

Core Principle 7 – Availability of General Information: The amendments to the Rules provide clarity to Exchange Participants. The amended Rules are available to market authorities, Participants, Authorized Brokers and the public on the Exchange website.

Core Principle 11 – Financial Integrity of Transactions: The applicable Futures contracts will continue to be cleared by Nodal Clear, a registered derivatives clearing organization subject to Commission regulation, and carried by qualified futures merchants.

Pursuant to Section 5c(c) of the Act and the Commission’s Regulation 40.6, the Exchange certifies that amended Rules comply with the Act and the Commission’s Regulations thereunder. There have not been any opposing views expressed regarding the amendments to the Rules.
